Based on law of associations rendered on August 3rd, 1909, namely article 6 thereof;

Based on the circular No. 10/a.m./2006 dated 19/5/2006 and amendment thereof No.15/a.m/2008 dated 12/9/2008;

Based on the notice submitted to the Ministry of Interior and Municipalities by the founders of the association known under the name of: “Dayaat Al Risala” and registered before the common administrative directorate under No. 15323 dated 26/9/2011;

Based on the proposition of the Director General of Political Affairs and Refugees by proxy;

The Minister of Interior and Municipalities Decrees the following:

Article 1: The Ministry of Interior and Municipalities was notified about the foundation of the association known under the name of:

“Dayaat Al Rissala”.

Headquarters: Dekwaneh, Slav Street, plot No. 9/1035 – El Ghazal Bldg. – ownership of Claude Mtanios El Khoury – ground floor – district of Meten.

Objective:

“Dayaat Al Rissala” association is a charitable association that works on serving Man from childhood to old age by providing care to children who are orphans, battered and abandoned on the streets, loving each person with all his weaknesses and strengths, in sickness and in health, in ignorance and in knowledge, living such love and expressing it by serving and through the construction and establishment of an orphanage and home for the elderly and by caring for persons with special needs, providing their least requirements, giving them a role in society and developing their human capacities.

Provided that the aforementioned shall be implemented according to laws and regulations in forced following the approval of competent authorities.

the provisions of the law published as per decree No. 10830 dated 9/10/1962 and the amendments thereof.

Article 4: The present advice and notification shall be served whenever required.
